

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT
BRENTWOOD REGIONAL COMMUNITY CHEST

This RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT (this "Agreement") is executed on this ____ day of _____, 2020 by _____ ("Volunteer/Participant").

In consideration of Volunteer and/or Participant and all persons under his/her custody and control being granted permission to assist with **BRENTWOOD REGIONAL COMMUNITY CHEST CHRISTMAS BASKET PREPARATION AND DISTRIBUTION EVENTS**, (collectively the "Event") the mutual covenants and agreements contained in this Agreement, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, it is agreed as follows:

1. The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.
2. BRENTWOOD REGIONAL COMMUNITY CHEST has put in place preventative measures to reduce the spread of COVID-19 at our volunteer food distribution events; however, we cannot guarantee that you will not become infected with COVID-19. Further, attending a food distribution event could increase your risk and your child(ren)'s risk of contracting COVID-19.
3. Volunteer and/or Participant for him/herself and all person's under his/her custody and control, HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to the EVENT whether caused by the COVID-19 INFECTION, NEGLIGENCE OF BRENTWOOD REGIONAL COMMUNITY CHEST or otherwise.
4. Volunteer and/or Participant for him/herself, all person's under his/her custody and control, and their respective heirs or assigns, does hereby fully and forever release, acquit, discharge, and agrees not to sue BRENTWOOD REGIONAL COMMUNITY CHEST, its subcontractors, affiliated companies, officers, agents, employees, and assigns (collectively "BRCC"), for any and all loss or damage and any claim or demands therefore on account of injury to the person or property or resulting in the death Volunteer and/or Participant arising out of or related to the event whether caused by the negligence of BRCC or otherwise.
5. Volunteer and/or Participant for him/herself, all person's under his/her custody and control, and their respective heirs, executors, administrators, successors and assigns, to indemnify, defend and hold harmless BRCC, FROM ANY LOSS, LIABILITY, DAMAGE OR COST they may incur arising out of or related to the EVENT(S) WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT. I UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO ME. I HAVE FULL AUTHORITY TO EXECUTE THIS AGREEMENT ON MY OWN BEHALF ALL PERSONS UNDER MY CUSTODY AND CONTROL ATTENDING THE EVENT. I INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
